
- European Agency since 2005

CEPOL European Police Exchange Programme - Framework

- EC / CEPOL covers
 - ✓ Cost for flight
 - ✓ Cost for hotel (half board basis)
 - eventually lunch and domestic transport
 has to be covered by sending country
- Exchange period
 - ✓ 13 days / 12 nights
 - ✓ if both parties agree the period could be shortened to five working days
- Mutual Exchange
 - ✓ host Exchangee and Exchangee host


